- 3. Storage of Goods. Once the Goods are in the possession of the Consignee, Consignee assumes all responsibility for the security of said Goods from risk of loss, theft or damage.
- 4. Fees. In consideration for the Resale Services, Consignee shall be entitled to retain twenty percent (20%) of the receipts from the sale of the Goods (the "Consignment Fee") inclusive of all costs and expenses incurred by Consignee in the process of rendering the Resale Services.
- 5. Payment. Consignor will be sent payment on the 10th (give or take a day or two) of each month for the Goods (minus Consignee's Consignment Fee) sold the previous month. Consignor will receive the payment, once customer has paid in full.
- 6. Insurance. The Consignee carries insurance on the Consignor's goods while on the property and when shipped to the customer.
- 7. Termination. Either party may terminate this Agreement at any time and for any reason upon written notice to the other party. If a termination notice is tendered by the Consignor after Consignee enters into an agreement with a buyer for the sale of any Goods, the termination of the Agreement shall be effective after said sale occurs. We will attempt to sell you items in a timely manner, but cannot guarantee how long it may take. We ask for at least 90 days before asking for the return of your items. Any items returned to you within 90 days of Consignment will be subject to a fee of \$30 or 10% of the asking price, whichever is greater. Federal regulations will be followed regarding the return of firearms. You are responsible for all shipping costs on returns.
- 8. Entire Agreement. This Agreement contains the full and complete understanding and agreement of the parties.
- 9. Modifications. This Agreement may not be modified or amended except in a written document signed by both parties.
- 10. Governing Law. This Agreement shall be governed by and construed in accordance with the internal laws of the State of Wisconsin. Any actions or suits involving the Agreement shall be litigated in the Circuit Court for Marathon County, Wisconsin.

11. Counterparts. This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Agreement delivered by e-mail or other electronic means is deemed to have the same legal effect as the original.
